Session Title: College Tech Talk 2025

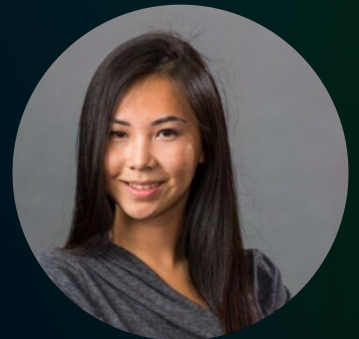
Speakers: Heather Biggar (BDSce, MSc, DHP), **Ashley Le** (RPhT), **Ed Diaz** (RPhT),

Session Title: Uprooting Pharmacy: A Two-Eyed Seeing Path for Change

Speakers: Jason Min (BSc(Pharm), PharmD, RPh), **Larry Leung** (BSc(Pharm), PharmD, RPh)

Dr. Jason Min is an Associate Professor of Teaching at the Faculty of Pharmaceutical Sciences, University of British Columbia. He is the co-founder of the research lab, UPROOT, which supports decolonizing and Indigenizing efforts in pharmacy education, practice, and research. Jason's teaching and research interests also include psychiatry, interprofessional education, and he is currently Academic Lead for the

national Academic Electronic Health Record (aEHR) application.

Dr. Larry Leung is an Associate Professor of Teaching at the Faculty of Pharmaceutical Sciences, University of British Columbia. He is the co-founder of the research lab, UPROOT, which supports decolonizing and Indigenizing efforts in pharmacy education, practice, and research.



Session Title: Protecting Patients and Practice: Drug Diversion Awareness for Pharmacy Technicians

Speaker: Deborah Heidary (RPhT)

Deborah Heidary is the Pharmacy Compliance Lead for Lower Mainland Health Authorities of British Columbia, servicing Providence Health, Vancouver Coastal Health, Provincial Health Services Authority, and Fraser Health. She has spent a lifetime in pharmacy, being employed since high school, graduating from the Humber College Pharmacy Technician Program, certified as a Pharmacy Technician

with the Ontario College of Pharmacists, and working in small and large community pharmacies, then moving to Vancouver and securing employment as a pharmacy technician at Vancouver General Hospital. She became a regulated pharmacy technician in 2013 with the College of Pharmacists of British Columbia, then took on district roles as a pharmacy technician within the Lower Mainland as an Inventory Control Technician and a Medication Use Evaluation Technician. Deborah is also part of the College's Registration Committee and takes part in the Pharmacy Examining Board of Canada. From all these experiences and being open to new opportunities, she has been able to bring leverage her skills in leading health science professionals in the detection, investigation, and prevention of drug diversion.

Session Title: A Dose of Ambition: Breaking Barriers for Pharmacy Technicians

Speaker: Fiona Lowe (RPhT)

Fiona Lowe is currently the Head of Commercial at Hikma Canada, where she leads national strategy and operations across the hospital and institutional portfolio. She began her career as a pharmacy technician, gaining invaluable frontline experience in hospital settings. This hands-on role brought her close to patients and gave her a deep, practical understanding of hospital workflows and the healthcare environment. She transitioned to Medbuy as a Coordinator for Pharmacy Services, where she worked directly with pharmaceutical companies to lead RFP processes and played a key role in managing drug shortages, a critical function in ensuring continuity of care. In 2019, Fiona joined GS1 as Senior Manager, Industry Relations, Pharmacy and Healthcare, where she recognized the lifesaving impact of barcoding and traceability on patient safety. This was a turning point that deepened her commitment to innovation in healthcare systems. She later joined Teligent as the National Hospital and Institutional Account Manager, and following Hikma Pharmaceuticals' acquisition of Teligent, Fiona was appointed Head of Commercial, where she continues to apply her extensive expertise in pharmacy, procurement, and healthcare systems to drive impactful commercial outcomes.

Kathryn (Kate) McKenzie has a B.Sc. from Simon Fraser University in Chemistry and Biology.
